Minutes Kick-off meeting New Strategic Development Plan (SDP) 1 February 2022 - 12:00-16:00 CET

The Forum for INTOSAI Professional Pronouncements (FIPP) / the three Goal Chairs - Capacity Building Committee (CBC), Knowledge Sharing Committee (KSC) and Professional Standards Committee (PSC)

The first day of the FIPP 2022 February-meetings was initiated as a SDP kick-off meeting for an initial discussion with all Goal Chairs.

Meeting material is distributed prior to the meeting. Appendix 1 is The draft process - new SDP

- 1. The draft process for discussion
- 2. The discussion paper to support the first discussion about possible content in the SDP
- 3. Outline for the SDP this will also be discussed at a later stage

The meeting was divided in 4 parts.

Part 1. Initial discussion between FIPP and all three GCs about the suggested process

Aim: Ensure clear roles and responsibilities and enable us to deliver a process for the PSC-SC in June

FIPP Chair gave an introduction to the content of the discussions on the agenda.

The new SDP should respond to the needs of the INTOSAI community as well as to update the existing framework. The draft process-plan presented by FIPP at this meeting have been designed based on the feedback from the INTOSAI community and feedback by the PSC SC and subcommittees under the PSC amongst others gathered at the PSC SC 19 October 2021. For better understanding of the presented process-plan a preliminary draft outline is also presented - for discussion. The SDP process-plan will after a consolidation and alignment with the GCC be distributed for approval at the upcoming PSC SC in May (?) 2022. In order to arrive at a new SDP to be presented for the Governing Board in 2023 the aim is to accommodate to involvement for all parties at the correct stages in order for proper and good discussions where the goal is an SDP that reflect the needs.

The highlights of the major changes done compared to the previous process are:

- 1. We suggest that subcommittees and working groups are invited to give their initial inputs at an early stage through the relevant goal chair. These inputs should feed into the draft plan to be discussed in an in-person meeting prior to the public consultation.
- 2. We suggest sending out a draft plan for consultation with stakeholders and INTOSAI members and bodies rather than an open invitation. This will enable us to get feedback both on the suggested plan as well as the gaps and projects that potentially are missing.

The Goal Chairs were overall in agreement with the suggested SDP draft process-plan, and complimented the suggested major changes presented as a useful means in the production of a united and relevant endresult. The early involvement of the subcommittees and working groups is a need that has been addressed in earlier discussions and is a valuable change to the process. Further all GCC was in agreement that the proposed timing of the stages in the draft were realistic and doable within the set timeframe.

The draft process will be made more easily visually accessible for involved parties prior to a finalization and distribution to the PSC SC.

FIPP will make available a cover paper with a template to be used if wanted by the Goal Chairs in their initial information gathering discussions with their respective subcommittees and working groups.

Each Goal Chair will be responsible for the final summing up to the FIPP for their respective subcommittee/working group. This input will be discussed at the FIPP June meeting 2022 together with the relevant results in the IDI stocktaking report and information from the ISLO network and the regions (members in the PSC SC) - facilitated by the PSC Secr.

It was also foreseen that the results of Component 1 will provide an important input into the next SDP. It was therefore agreed that the process-plan should show how the results of Component 1 will feed into the process.

The external information gathering to follow in autumn 2022 will be distributed to both the INTOSAI community and external stakeholders.

Conclusion: the CBC, KSC and PSC were in overall agreement with the proposed draft process plan at the meeting. For minor changes and suggestions to alignments the three Goal Chairs are invited to distribute these by email after the meeting.

Part 2. Each goal chair presents their goal (according to the latest version of the new SP) and reflect on how, in their opinion, the IFPP can be used to underpin their respective goal.

Aim: to identify what the SP means to the SDP and if this potentially affects the drafting process

Part 2 is a discussion agenda item - no conclusion.

The three Goal Chairs presented their respective goal from the latest version of the new strategic plan (SP). The group discussed the SP goals and their implications of the SDP process and plan as well as on the updating of the current IFPP and future communication strategy for the INTOSAI community.

Part 3. FIPP and GCs discuss important topics that will influence the SDP according to discussion paper

Aim: to ensure an agreed understanding of initiatives that have already started and the capacity available for other initiatives

We will start an initial discussion in the upcoming meeting to reflect on the following questions:

- 1. Can we agree on a vision and a strategy or priorities for the new SDP? This will guide us when deciding what sort of process we need, what kind of projects we should propose and how many projects we can include in the plan. Examples of priorities:
 - a. Focus on the ISSAIs
 - b. Focus on the SAI level (INTOSAI Ps and the organisational requirements)
- 2. Other questions for discussion:
 - a. The INTOSAI SP focus on independent SAIs and the SDGs. How can the new SDP support the vision of the new SP?

- b. The IDI global stocktaking report highlights that there is still a long way to go to achieve implementation of the ISSAIs. How should conclusions in this report be reflected in the SDP?
- c. The Component 1 discussion took place through 2020-2021. We need to consider the conclusions from the C1 project and how these feed into the next SDP.
- 3. Consider the future of the GUIDs. We have a big group of GUIDs that are audit related and many of these are pre-IFPP documents. We need to decide the future of this class of pronouncements:
 - a. Should we keep the pre-IFPP documents or should they be updated or removed from the framework?
 - b. Shall we continue to develop new GUIDs and should they be only related to the SAI level or the auditor or do we also allow for other kind of GUIDs?
 - c. Should GUIDs continue to be part of the IFPP? What is the consequence if they are moved outside the framework?

The agenda item Part 3 is an initial discussion item. No conclusion.

The Goal Chairs and FIPP had an initial discussion of the sub questions of the Part 3 where they started to explore the need for a possible long-term vision in regards of priority and resources, predictability and clarification.

The joint discussion will continue at the FIPP April 2022 and June 2022 meetings, at a later stage to also involve the subcommittees and working groups and be part of the process towards a SDP proposal.

Part 4. FIPP and GCs discuss the outline for the SDP.

Aim: To identify any needs to update the process and to decide how and when the PSC-SC should be involved in "producing" the SDP

The preliminary draft of the outline will be updated accordingly to the inputs from the group at this meeting and by the written comments from the GCC after the meeting. The preliminary draft of the outline is meant as a tool for the PSC SC when discussing/approving the SDP process at the PSC SC meeting in May(?) and will not be part of any approval. If feasible the group will seek to include a draft text on the overall vision for the IFPP in order to support a first discussion in the PSC SC on the vision.

The preliminary draft of the outline with vision and a possible set of overall goals will be further discussed with the group (FIPP/GCC) at the FIPP June meeting.
