Discussion on the Project proposals	FIPP internal discussion to improve the feedback to the projects and potentially identify further areas for improvement in order for FIPP to approve the project proposals. Cooperation in FIPP and with project groups	<p>The new SDP 2023-2028 Initiatives represent a different type of projects, with different output compared to traditional IFPP standards projects.</p> <p>This shift has highlighted the need for updating the FIPP Working procedures, which no longer fully reflect the actual way of working in FIPP.</p> <p>In addition, with a relatively large number of new members in FIPP, it is necessary to have a discussion on how FIPP, particularly through the new LO-groups, should work with the Project groups to effectively assist them in their task.</p> <p>FIPP will use this input from this discussion to update the FIPP working procedures</p>	A list of good practices or common "rules" for communication and cooperation between FIPP and initiatives as well as what to bring up in different foras, such as FIPP, core group, PSC-SC.
